Description: Required by State Statute, the Loss Trust Fund Board makes recommendations to the City Council

regarding the administration of the loss trust fund. The trustees meet at least once a year and submit a report to the City Council regarding the status of the trust fund. The report includes

recommendations the trustees deem necessary.

Special Qualifications: As specified in the Scottsdale City Code, the City Council appoints five joint trustees, of whom no more than one shall be a member of the City Council and no more than one trustee may be a City employee.

Purpose:

Powers and Duties:

S.R.C., Sec. 2-171. - Advisory trustees

- (a) The City Council shall appoint five (5) joint trustees, of whom no more than one (1) shall be a member of the City Council. No more than one (1) trustee may be a City employee.
- (b) The trustees shall be responsible for recommendations to the City Council regarding the administration of the loss trust fund. The trustees shall meet at least once a year and submit a report to the City Council as to the status of the trust fund. Such report shall include recommendations the trustees deem necessary.
- (c) The trustees shall be bonded in a minimum amount of ten thousand dollars (\$10,000.00) each. Costs for bonding shall be paid by the City.

Bylaws:

Bylaws were adopted by the Loss Trust Fund Board on January 20, 2010.

Bylaws Provisions:

Purpose

Organization: membership, elections, officers, terms, staff liaison, resignation to seek public office, member resignations and vacancies, committees, legal counsel

Clarification of meeting times, locations and procedures: quorum, absence of chair and vice chair, member attendance, public comment, presentation, time limitations, agendas, conflict of interest, abstention, member conduct, conduct by the public

Official records: records included, retention of files, recording of vote, public record

Rules and amendments: bylaws amendment procedure, written communications, public representations, presentations and communications, Robert's Rules of Order

Absences (Bylaws): The Chair may recommend that the Council remove and replace any member who is absent from three (3) consecutive regular meetings.

The original ordinance specified that no more than one council member and no more than one staff member could be on the board (of trustees).
