

RESOLUTION NO. 10268

**A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, ARIZONA,
DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF
SCOTTSDALE SPECIAL ELECTION HELD NOVEMBER 3, 2015.**

WHEREAS, pursuant to Article 9, Section 1 of the Scottsdale City Charter, the City of Scottsdale, Arizona, held a Special Election on November 3, 2015, for the purpose of submitting six ballot measures to the voters of Scottsdale; and

WHEREAS, on June 3, 2015, the Council of the City of Scottsdale adopted Resolution No. 10139, entitled, "A resolution of the Council of the City of Scottsdale, Arizona, ordering and calling a Special Election to be held in and for the City of Scottsdale, Arizona on Tuesday, November 3, 2015, to submit to the qualified electors thereof the questions of authorizing the issuance and sale of \$95,960,000 principal amount of general obligation bonds; and designating or providing for the manner in which the City Clerk shall conduct the election, Spanish translation of election materials, deadline for voter registration, early voting dates, and type of voting system to be used"; and

WHEREAS, six bond questions were submitted to the voters at the November 3, 2015 Special Election as Question 1, Question 2, Question 3, Question 4, Question 5, and Question 6; and

WHEREAS, A.R.S. § 35-454 requires the City Council to meet within twenty (20) days after the election to canvass the votes cast and certify the results of the bond election; and

WHEREAS, the City Council, having canvassed the returns of the November 3, 2015 Special Election, finds the returns to be as stated in this resolution;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Scottsdale as follows:

1. The results of the election having been determined, the official canvass of the City of Scottsdale Special Election held on November 3, 2015 is as follows:
 - a) A summary of the number of votes cast in each voting district for each question is shown on Exhibit A, which is attached and incorporated by this reference.
 - b) A precinct group detail of the number of rejected ballots by voting district is shown on Exhibit B, which is attached and incorporated by this reference.
2. Question 1, which seeks voter authorization to sell \$31,900,000 general obligation bonds for parks and community facilities, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.
3. Question 2, which seeks voter authorization to sell \$16,540,000 general obligation bonds for transportation, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.



4. Question 3, which seeks voter authorization to sell \$6,870,000 general obligation bonds for citywide technology, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.
5. Question 4, which seeks voter authorization to sell \$12,500,000 general obligation bonds for street pavement replacement, having received a number of votes that was more than a majority of the votes cast, was approved by the qualified voters.
6. Question 5, which seeks voter authorization to sell \$16,350,000 general obligation bonds for public safety-fire, having received a number of votes that was more than a majority of the votes cast, was approved the qualified voters.
7. Question 6, which seeks voter authorization to sell \$11,800,000 general obligation bonds for public safety-police, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.



UNA RESOLUCIÓN DEL CONCEJO DE LA CIUDAD DE SCOTTSDALE, ARIZONA, DECLARANDO EL ESCRUTINIO OFICIAL DE LOS VOTOS EMITIDOS EN LA ELECCIÓN ESPECIAL DE LA CIUDAD DE SCOTTSDALE EL 3 DE NOVIEMBRE DE 2015.

VISTO QUE, de acuerdo con el Artículo 9, Sección 1 de la Constitución de la Ciudad, la Ciudad de Scottsdale, Arizona, celebró una Elección Especial el 3 de noviembre de 2015, con el propósito de presentarles seis medidas de la boleta a los votantes de Scottsdale; y

VISTO QUE, el 3 de junio de 2015, el Concejo de la Ciudad de Scottsdale adoptó la Resolución No. 10139, titulada, "Una resolución del Concejo de la Ciudad de Scottsdale, Arizona, ordenando y convocando una Elección Especial que se celebrará en y para la Ciudad de Scottsdale, Arizona en martes, 3 de noviembre de 2015 para presentarles a los electores capacitados de esa las cuestiones de autorizar la emisión y venta de bonos de obligación general en una cantidad principal de \$95,960,000; y designando o proveyendo por la manera en que la Secretaria Municipal deberá administrar la elección, traducción al Español los materiales electorales, fecha tope de la inscripción como votante, fechas de la votación antes de la elección, y tipo de sistema de votación que se usará"; y

VISTO QUE, seis cuestiones de bonos se les presentaron a los votantes en la Elección Especial del 3 de noviembre de 2015 como la Cuestión 1, Cuestión 2, Cuestión 3, Cuestión 4, Cuestión 5, y Cuestión 6; y

VISTO QUE, Los Estatutos Revisados de Arizona (A.R.S.) § 35-454 ordenan que el Concejo de la Ciudad se reúne dentro de veinte (20) días después de la elección para hacer el escrutinio de los votos emitidos y certificar los resultados de la elección de bonos; y

VISTO QUE, el Concejo de la Ciudad, habiendo hecho el escrutinio de los resultados de la Elección Especial del 3 de noviembre de 2015, encuentra los resultados ser como se declaran en esta resolución;

AHORA, POR CONSIGUIENTE, RESUELVE el Concejo de la Ciudad de Scottsdale como lo siguiente:

1. Habiendo determinado los resultados de la elección, el escrutinio oficial de la Elección Especial de la Ciudad de Scottsdale que se celebró el 3 de noviembre de 2015 es como lo siguiente:
 - a) Un resumen del número de los votos emitidos en cada distrito de votación por cada cuestión se muestra en el Documento de Prueba A, adjunto e incorporado por esta referencia.
 - b) Un detalle por grupo de precintos del número de boletas rechazadas por distrito de votación se muestra en el Documento de Prueba B, adjunto e incorporado por esta referencia.

2. Cuestión 1, que solicita autorización de los votantes para vender bonos de obligación general en una cantidad de \$31,900,000 para parques e instalaciones de la comunidad habiendo recibido un número de votos que fueron menos que una mayoría de los votos emitidos, fue rechazada por los electores capacitados.
3. Cuestión 2, que solicita autorización de los votantes para vender bonos de obligación general en una cantidad de \$16,540,000 para transportación, habiendo recibido un número de votos que fueron menos que una mayoría de los votos emitidos, fue rechazada por los electores capacitados.
4. Cuestión 3, que solicita autorización de los votantes para vender bonos de obligación general en una cantidad de \$6,870,000 para tecnología por toda la ciudad, habiendo recibido un número de votos que fueron menos que una mayoría de los votos emitidos, fue rechazada por los electores capacitados.
5. Cuestión 4, que solicita autorización de los votantes para vender bonos de obligación general en una cantidad de \$12,500,000 para reemplazar el pavimento de las calles, habiendo recibido un número de votos que fueron más que una mayoría de los votos emitidos, fue aprobada por los electores capacitados.
6. Cuestión 5, que solicita autorización de los votantes para vender bonos de obligación general en una cantidad de \$16,350,000 para seguridad pública de incendios, habiendo recibido un número de votos que fueron más que una mayoría de los votos emitidos, fue aprobada por los electores capacitados.
7. Cuestión 6, que solicita autorización de los votantes para vender bonos de obligación general en una cantidad de \$11,800,000 para seguridad pública de policía, habiendo recibido un número de votos que fueron menos que una mayoría de los votos emitidos, fue rechazada por los electores capacitados.
