

RESOLUTION NO. 9583

**A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, ARIZONA,
DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF
SCOTTSDALE SPECIAL ELECTION HELD NOVEMBER 5, 2013.**

WHEREAS, pursuant to Article 9, Section 1 of the Scottsdale City Charter, the City of Scottsdale, Arizona, held a Special Election on November 5, 2013, for the purpose of submitting five ballot measures to the voters of Scottsdale; and

WHEREAS, on April 9, 2013, the Council of the City of Scottsdale adopted Resolution No. 9348, entitled, "A resolution of the Council of the City of Scottsdale, Arizona, ordering and calling a Special Election to be held in and for the City of Scottsdale, Arizona on Tuesday, November 5, 2013 to submit to the qualified electors thereof the questions of authorizing the issuance and sale of \$212,100,000 principal amount of General Obligation Bonds; and designating or providing for the manner in which the City Clerk shall conduct the election; Spanish translation of election materials; deadline for voter registration; early voting dates, if necessary; and type of voting system to be used"; and

WHEREAS, four bond questions were submitted to the voters at the November 5, 2013 Special Election as Question 1, Question 2, Question 3, and Question 4; and

WHEREAS, on May 14, 2013, the Council of the City of Scottsdale adopted Resolution No. 9405, entitled, "A resolution of the City of Scottsdale, Maricopa County, Arizona, deeming the proposed EPCOR and Chaparral City Water Company Franchise Agreement 2013-062-COS beneficial to the City; submitting the question as to whether or not the franchise shall be granted to a vote of the qualified electors of the City at the special election to be held on November 5, 2013; and estimating related election costs to be paid by EPCOR and Chaparral City Water Company"; and

WHEREAS, the proposed EPCOR and Chaparral City Water Company Franchise Agreement 2013-062-COS was submitted to the voters at the November 5, 2013 Special Election as Question 5; and

WHEREAS, A.R.S. § 16-642 requires that the City Council canvass the returns of the election not less than six (6) days nor more than twenty (20) days following the election, and A.R.S. § 35-454 requires the City Council to meet within twenty (20) days after the election to canvass the votes cast and certify the results of the bond election; and

WHEREAS, the City Council, having canvassed the returns of the November 5, 2013 Special Election, finds the returns to be as stated in this resolution;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Scottsdale as follows:

1. The results of the election having been determined, the official canvass of the City of Scottsdale Special Election held on November 5, 2013 is as follows:



- a) A summary of the number of votes cast in each voting district for each question is shown on Exhibit A, which is attached and incorporated by this reference.
- b) A precinct group detail of the number of rejected ballots by voting district is shown on Exhibit B, which is attached and incorporated by this reference.
2. Question 1, which seeks voter authorization to sell \$50,400,000 general obligation bonds for parks, libraries and community facilities, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.
3. Question 2, which seeks voter authorization to sell \$43,700,000 general obligation bonds for public safety, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.
4. Question 3, which seeks voter authorization to sell \$19,000,000 general obligation bonds for neighborhood flood protection and storm sewers, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.
5. Question 4, which seeks voter authorization to sell \$99,000,000 general obligation bonds for transportation, streets and trails, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.
6. Question 5, which asks voters to consider whether a franchise shall be granted to EPCOR Water Arizona Inc. and Chaparral City Water Company to maintain and operate a potable water distribution system in the City of Scottsdale, and future additions thereto, in accordance with the agreement submitted by the Mayor and City Council in Resolution No. 9405, having received a number of votes that was less than a majority of the votes cast, was rejected by the qualified voters.





UNA RESOLUCIÓN DEL CONCEJO DE LA CIUDAD DE SCOTTSDALE, ARIZONA, DECLARANDO EL ESCRUTINIO OFICIAL DE LOS VOTOS EMITIDOS EN LA ELECCIÓN ESPECIAL DE LA CIUDAD DE SCOTTSDALE QUE SE CELEBRÓ EL 5 DE NOVIEMBRE DE 2013.

VISTO QUE, de acuerdo con el Artículo 9, Sección 1 de la Constitución de la Ciudad de Scottsdale, la Ciudad de Scottsdale, Arizona celebró un Elección Especial el 5 de noviembre de 2013, con el propósito de presentarles a los votantes de Scottsdale cinco medidas de la boleta; y

VISTO QUE, el 9 de abril de 2013, el Concejo de la Ciudad de Scottsdale adoptó la Resolución No. 9348 titulada, "Una resolución del Concejo de la Ciudad de Scottsdale, Arizona ordenando y convocando una Elección Especial que se celebrará en y para la Ciudad de Scottsdale, Arizona en martes, 5 de noviembre de 2013 para presentarles a los electores habilitados de esa las cuestiones de autorizar la emisión y venta de Bonos de Obligación General en la suma principal de \$212,100,000; y designando o proveyendo por la manera por cual la Secretaria Municipal deberá administrar la elección; traducción al Español de los materiales electorales; fecha tope para inscripción como votante; fechas de la votación temprana, y si necesario; el tipo de sistema de votación que se usará"; y

VISTO QUE, cuatro cuestiones de bonos se les presentaron a los votantes en la Elección Especial del 5 de noviembre de 2013 como la Cuestión 1, Cuestión 2, Cuestión 3, y Cuestión 4; y

VISTO QUE, el 14 de mayo de 2013, el Concejo de la Ciudad de Scottsdale adoptó la Resolución No. 9405, titulada, "Una resolución de la Ciudad de Scottsdale, Condado Maricopa, Arizona, decidiendo que el propuesto Contrato de Franquicia de EPCOR y Chaparral City Water Company 2013-062 -COS ser de beneficio para la Ciudad; sometiendo la cuestión de que si o no se le debe conceder el voto de los electores capacitados de la Ciudad en una elección especial que se celebrará el 5 de noviembre de 2013; y calculando los costos relacionados con la elección que pagará EPCOR y Chaparral City Water Company"; y

VISTO QUE, el propuesto Contrato de Franquicia de EPCOR y Chaparral City Water Company 2013-062-COS se les presentó a los votantes en la Elección Especial del 5 de noviembre de 2013 como la Cuestión 5; y

VISTO QUE, los Estatutos Revisados de Arizona § 16-642 ordenan que el Concejo de la Ciudad complete el escrutinio de los resultados de la elección no menos de seis (6) días ni más de veinte (20) días después de la elección, los Estatutos Revisados de Arizona § 35-454 ordenan que el Concejo de la Ciudad se reúna dentro de veinte (20) días después de la elección para completar el escrutinio de los votos emitidos y certificar los resultados de la elección de bonos; y

VISTO QUE, el Concejo de la Ciudad, habiendo completado el escrutinio de los resultados de la Elección Especial del 5 de noviembre de 2013, encuentra los resultados ser como se declaran en esta resolución;

AHORA, POR CONSIGUIENTE, RESUELVE el Concejo de la Ciudad de Scottsdale como lo que sigue:

1. Los resultados del escrutinio se han determinado, el escrutinio oficial de la Elección Especial de la Ciudad de Scottsdale que se celebró el 5 de noviembre de 2013 son como lo que sigue:
 - a) Un resumen del número de votos emitidos en cada distrito electoral para cada cuestión se muestra en el Documento de Prueba A, adjunto a esto e incorporado por esta referencia.
 - b) Una explicación detallada de todos los precintos del número de boletas rechazadas por distrito se muestra en el Documento de Prueba B, adjunto a esto e incorporado por esta referencia.
2. Cuestión 1, procura la autorización de los votantes de vender bonos de obligación general en una cantidad de \$50,400,000 para los parques, bibliotecas e instalaciones de la comunidad, recibió un número de votos que fue menos que una mayoría de los votos emitidos, fue rechazada por los votantes capacitados.
3. Cuestión 2, procura la autorización de los votantes de vender bonos de obligación general en una cantidad de \$43,700,000 para la seguridad pública, recibió un número de votos que fue menos que una mayoría de los votos emitidos, fue rechazada por los votantes capacitados.
4. Cuestión 3, procura la autorización de los votantes de vender bonos de obligación general en una cantidad de \$19,000,000 para protección contra inundaciones de las vecindades, recibió un número de votos que fue menos que una mayoría de los votos emitidos, fue rechazada por los votantes capacitados.
5. Cuestión 4, procura la autorización de los votantes de vender bonos de obligación general en una cantidad de \$99,000,000 para transportación, las calles y senderos, recibió un número de votos que fue menos que una mayoría de los votos emitidos, fue rechazada por los votantes capacitados.
6. Cuestión 5, les pide a los votantes considerar si se le deberá otorgar a EPCOR Water Arizona Inc. y Chaparral City Water Company para mantener y operar un sistema de distribución de agua potable en la Ciudad de Scottsdale, y adiciones en el futuro a eso, de acuerdo con el contrato sometido por el Alcalde y el Concejo Municipal en la Resolución No. 9405, recibió un número de votos que fue menos que una mayoría de los votos emitidos, fue rechazada por los votantes capacitados.
