# Ordinance No. 4372 Bicycle and Related Devices

City Council Meeting November 13, 2018

1

Bicycles, electric/motorized bicycles and stand-up electric mini-scooters are covered by the ordinance

Key Question: where <u>don't</u> we want these devices?

### Key criteria:

- 1. Keep sidewalks open for pedestrians
- 2. Require owner to keep devices properly parked
- 3. Devices should be operable and used
- 4. Maintain aesthetics by proper spacing
- 5. Respect private property

### Keep sidewalks open for pedestrians

Parking is prohibited on a public sidewalk obstructing the pedestrian through zone (the portion of the sidewalk used primarily by pedestrians for travel, accessing transit or buildings).

### Require owner to keep devices properly parked

Devices should be parked in a rack or designated parking area, and 15 areas are outlined where parking is prohibited. Requires an owner such as a bike share company to remove an improperly parked device upon notification from any person within two hours.

### Devices should be operable and used

Inoperable devices must be removed within two hours after notification. It is illegal for devices to remain in the same location on public property for more than 72 hours. This requires them to be used at least once every three days. Improperly parked, inoperable or abandoned devices may be impounded.

### Maintain aesthetics by proper spacing

There is a maximum of five parked devices by the same owner within 200 feet (unless authorized by city permit, such as a special event permit). This helps address aesthetics issues seen particularly in Old Town. The police chief or designee may designate or limit device parking areas if particular areas become problematic.

### Respect private property

Devices can only be on private property with owner permission (except commercial and multi-family residential property if located in racks or designated parking areas).

### Additional public safety requirements

Stand-up electric mini-scooters and most electric bikes would be allowed on sidewalks and shared-use paths. However, Class 3 electric bicycles will continue to be prohibited on paths and sidewalks. Stand-up electric mini-scooters will be limited to roadways with speed limits of 35 mph or less. Travel at speeds greater than reasonable and prudent is prohibited, as is operation with reckless disregard for safety, and device use under the influence of alcohol or drugs.

### What if Ordinance No. 4372 isn't enough?

### **Petition to City Council**

Continue our use of the outside of the Livery Stable so we may keep the presence of horses in Historic Old Town and continue Stagecoach and Carriage Services in Old Town Scottsdale

To re-cap:

Upon receiving an unexpected notice by the Tourism Department on September 7<sup>th</sup>, to vacate our entire business out of the Livery Stable by the end of this year, we came to City Council on September 11<sup>th</sup> and Petitioned City to continue our existing contract with the 2 years it had left, subsidizing Stagecoach Rides, which allowed for us to continue our full time Stagecoach and Carriage Services in Old Town Scottsdale.

Since our last Petition, that was requesting continued subsidy from the City for Stagecoach Rides and City Events... when the community learned that the City no longer wanted to subsidize the last Stagecoach in Old Town, and it will be gone for good, we have had an overwhelming response from the Scottsdale Community to keep the Stagecoach. The Horse Community and private money has stepped up to sponsor the last Stagecoach in Old Town and has committed to sponsor us through the 2018/2019 Season pending the outcome of our Petition to keep us in Old Town.

On September 11<sup>th</sup>, we were deferred to Jim Thompson and the City Manager's office. We never had a meeting with Jim Thompson but did meet with the assistant staff, who prepared the City Managers report, denying our Petition.

The City Managers Report prepared by the assistant staff who made the denial decision, is just now learned to be the boss of Karen Churchard in the Tourism Department, who is ordering us to vacate.

There are several statements in the City Manager Report that need to be addressed.

Enclosed, you have the corrections to the City Managers Report, with 10 specific numbered items that are false inaccurate statements, misleading and unjust statements, that go against our 30 plus years of safety protocol with an impeccable record insured for 30 years without incident.

Please see #5 and #6 in corrections to City Manager Report. Never once in any email or meetings was it suggested we were to completely vacate the Livery. It was suggested the City MAY not want to do subsidized rides, but wanted us to continue paid rides from the Livery. It states in Karen Churchards emails that it didn't make sense to have subsidized rides next to paid rides and wanted us to continue paid rides, never once suggesting we had to vacate our entire business and at the same time expect us to stay in business.

The extensive training of our horses before any of them are put to work in the public venue of Old Town is a safety protocol that is unsurpassed, and our safety manuals are used for Carriage Company employee and horse training nationwide.

See # 8 Please see on corrected report for more details about our extensive training program, with every horse passing tests over 100 miles before they ever see Old Town.

Next: The City of Scottsdale proposed Horse and Carriage Ordinance is enclosed, that we authored in 2007 in efforts to keep Old Town safe. Please see #9 on corrected report:

We felt it necessary to provide the City with an Ordinance in 2007 when an unknown carriage operator who was uninsured with an untrained horse came to Old Town and ran into a City sign. That operator and his horse never came back.

This was never adopted, because we were the only Carriage Operator since then, who met all the requirements in the City Ordinance.

If we are forced out of business and forced out of Old Town, the City will still need this Ordinance to protect the City of Scottsdale.

The Tourism Department to "allow anyone to operate" invites uninsured people with no experience, no liability insurance and untrained horses, that will ultimately hold the City liable.

We have been the only Carriage company in Old Town for the past 12 years, and the only one left. No one in the City has been able to produce another Carriage Company that exists who is insured to meet industry standards, with horses that are trained in the public venue of Old Town to be safe, with training programs in place as protocol for safety.

Our greatest concern is to leave our historic legacy in Old Town, who helped make Scottsdale the West Most Western Town, with no horses at all. Or worse, out of town uninsured operators with untrained horses in the public venue of Old Town, that will compromise the safety and liability in Scottsdale that we worked our entire careers to keep safe.

Time is running out. As is, we are forced to vacate our entire business out of Old Town by December 31st midnight. We petition the City Council to put us on the next available City Council agenda, before it is too late. Our family has worked very hard to keep our horses in the West Most Western Town, and do not want to leave it without a Stagecoach and Carriage business, that is fully insured with horses that are trained to be in the public venue of Old Town Scottsdale.

We ask the City to please help us accomplish this, before it's too late.

It is of great concern as we stand by over 30 years of our safety record without incident and the extensive training we put our horses through before they ever work in Old Town Scottsdale.

As it stands now on our Petition, we must vacate the Livery Stable by Dec. 31st 2018 leaving no horses in Old Town. In review of 100's of City emails, not once was it ever mentioned or suggested we would have to vacate the Livery Stable, it was only discussed that the City no longer wanted to subsidize the City paid rides anymore and we would continue operating on paid rides only from the Livery stable.

We now Petition the City to provide a safe place for our Stagecoach and Carriages so that Old Town can continue to offer these services that are a part of Scottsdale history.

#### Petition:



On Sept. 11, 2018, Ms. Teri Todd presented the City Council with a petition requesting the Mayor and City Council overturn the decision made by Karen Churchard, Director of Tourism & Events, regarding the 2016 Horse and Carriage City Services and Revocable License Agreement.



The Council directed the City Manager to investigate the matter raised in the petition and to prepare a written report to the Council, with a copy to be provided to the petitioner. This memorandum is being submitted in response to that direction.

#### Background:

On January 1, 2016 the city entered into a 2016 Horse and Carriage City Services and Revocable License Agreement with Teri Todd, d/b/a Scottsdale Carriage for horse-drawn carriage services in Old Town Scottsdale. As a part of this Agreement, the city also made available the Livery Stable as a part of Scottsdale Carriage's compensation for providing these services. The term of the agreement was for a one-year period. The agreement also allows for a maximum of four additional one-year extensions upon the recommendation of the Downtown Specialist, who is the Contract Administrator, and concurrence of the Tourism and Events Director. The city has budgeted \$14,000 annually for the rides, and the real estate value of the storage space at the Noriega Livery Stable is about \$13,000/year.

All Tourism & Events Department extendable agreements are reviewed annually by the Downtown Specialist and the Tourism & Event Director. Last year, in December 2017, staff discussed not extending the Scottsdale Carriage contract. One concern was over the use of the Brown Avenue pullout to conduct the carriage business. On Dec. 20, 2017, Ms. Todd met with Assistant City Manager Brent Stockwell, and requested an extension because Scottsdale Carriage had recently renewed their annual city-required insurance in November at a cost of \$7,500. Following that meeting staff extended the agreement for six months through June 30, 2018. In addition, Ms. Todd requested that the extension decrease the number of days for free rides from three to two and increase the rate for Saturday afternoon rides from \$350 to \$500 per carriage ride. These requests were accommodated. In the summer, Ms. Todd asked for another extension through Sept. 30, 2018 allowing the continued storage of carriages at the Livery Stable.



On Aug. 8, 2018, the Tourism & Events Director and new Downtown Specialist met with Ms. Todd. It was made clear to Ms. Todd by Ms. Churchard that the city was considering not renewing the contract. At that time, Ms. Todd offered to sell the customized Old Town Scottsdale carriage to the city if it was decided not to continue free rides. Ms. Todd also stated that if the city were to extend, that Scottsdale Carriage no longer wanted to provide free rides during ArtWalk in the evening. Ms. Churchard stated several times that the city wanted and



encouraged Ms. Todd to continue paid carriage rides and that staff had met with the Police Department who ensured they would facilitate signing the Brown Avenue pull-out if there were established days and times paid carriage rides would be available. During the meeting, Ms. Todd did state she was unsure whether the company could sustain these services without a continued subsidy from the city.

Downtown Specialist Jackie Contaldo contacted Ms. Todd by phone on Aug. 10, 2018 and stated that the city would not be extending the agreement. Afterward Ms. Todd corresponded with staff about this decision and asked why the agreement was not being extended. Ms. Churchard replied in a Aug. 20, 2018 email stating:

"Thanks for your patience as we were following up on your prior email from last Monday afternoon as promised.

Last December, you met with Brent and your statement to him was that after the 2018 tourist season, since you had already invested in the insurance for the stagecoach, you were fine with ending the free rides if the city wanted to do that.

You asked for the agreement to be extended to recoup your insurance costs. You also wanted to make sure you had access to the Brown Avenue pull out. And, you asked for a change in Scope of Work to not provide Friday rides and for an increase in payment for Saturday afternoons from \$300 to \$500, all of which the city accommodated.

I am following through with discussions you had with Brent and Mary last year, and giving you notice that the city will not be extending the agreement past December 2018. It doesn't make sense for the city to subsidize some rides on Second Street, while paid rides are going on elsewhere in historic Old Town.

That being said, to be clear, the paid rides can still continue if you (or anyone else) wants to provide them. The city is also willing to sign the Brown Avenue pullout appropriately to provide waiting and respite time, if you provide in writing via email your hours of operation.

At our last meeting, you suggested that maybe the city would like to purchase the stagecoach you had customized "Old Town Scottsdale." We are interested in talking further about a possible purchase by the city. Please contact Jackie or me if you are still interested in discussing the purchase of the Old Town Scottsdale stagecoach."

Staff believe that paid rides could continue without the subsidy as Ms. Todd had stated that paid "walk-up rides represent 75 to 80 percent of Scottsdale Carriage earnings" and if this subsidy was removed that perhaps other carriage providers would be willing to provide paid rides in Old Town Scottsdale. Staff was also concerned about safety and risk to the city due to a horse carriage accident on January 14, 2018 involving Ms. Todd while training a new horse.

On Sept. 21, 2018, Assistant City Manager Brent Stockwell, Management Assistant Megan Lynn and Citizen Liaison Christy Hill met with Ms. Todd to talk through her concerns.

If Ms. Todd's contract is not extended, she would consider continuing to offer paid rides on the current route during the following time periods:

- December

   January: Operate Wednesday to Sunday, from 11 a.m. to dusk.
- February–March: Operate seven days per week, from 11 a.m. to dusk.

At the Sept. 21, 2018 meeting, Ms. Todd discussed the following conditions for her to continue to operate paid carriage rides in Old Town Scottsdale.

1. **Request:** Limit other vehicle use such as golf carts along the route to increase safety for both horses and carriage riders.





**Response:** Staff reviewed this possibility with the City Attorney's Office but were advised that per Arizona Revised Statute 28-143, these vehicles are not subject to further regulation by cities.

 Request: Have the City Council adopt an ordinance regulating carriage operators in Scottsdale.

**Response:** A draft ordinance was prepared in 2010 but was not presented for adoption by the City Council because there was not sufficient public interest to move forward. Staff reviewed this draft ordinance with the City Attorney's Office and determined that it is not necessary to begin regulating horse and carriage operations in Scottsdale.

3. **Request:** Explore the option of allowing Scottsdale Carriage continued use of the Livery Stable on a year-to-year basis while offering non-subsidized, paid-only rides.

**Response:** Staff reviewed this possibility and allowing Scottsdale Carriage exclusive use of this stable area for commercial purposes would be unfair to other potential operators. The real estate value of the storage space at the Noriega Livery Stable is about \$13,000/year or about \$1,080/month.

Request: Purchase the Scottsdale Stagecoach constructed by Ms. Todd for the paid rides.
 Ms. Todd stated that she constructed the Stagecoach for \$22,000 and felt the current value was \$30-40,000.

**Response:** Tourism and Events staff considered purchasing this Stagecoach, but the current offer is too expensive given that it would primarily be used as a prop for visitor photographs.

#### Conclusion:

Based on the above considerations, city staff does not recommend overturning the decision of the Tourism & Events Director to not extend the 2016 Horse and Carriage City Services and Revocable License Agreement. Further, city staff does not recommend that the city allow Ms. Todd continued exclusive use of the stable area to run her private business because it would disadvantage other potential carriage operators. Staff also does not recommend purchasing the stagecoach at the offered price of \$30-40,000. Ms. Todd is welcome to offer paid rides. This could potentially reduce her insurance costs, by removing the City required coverages.

#### **City Manager Report Corrections**

- 1) Petition to overturn Staff Decision on September 7th 2018 Carriage Agreement (not 2016)
- 2) The RFP Carriage Agreement was in 2015. (not 2016) We entered into another 5 year agreement in 2015, as with the previous 5 year Carriage Agreement in 2010. They have all been 5 year agreements.
- 3) December 2017 meeting, we dealt with golf cart issues and were seeking a Sole Source Contract, compared to the Singing Cowboy Contract that pays \$900 per 3 hour shift once a week. At the time, we were only being paid \$300 for many days and hours of services per week. We were denied a sole source contract and given a raise to \$500 per shift to cover rising costs to do business, such as carriage parts including wheel rubber, steel, leather and hickory wooden spokes, and insurance rates that went up. It was discussed in that meeting to do paid rides only out of the Livery Stable.
- 4) When we met with Karen Churchard of the Tourism Department in August this year, we were expecting an upcoming season of Events with dates and an annual extension on our contract as we have always had every year. We did not request a 6 month extension, that was what we were given. With no notice in any email or phone call of any cancelation of our entire contract. And the extension issued after the 6 month extension was only issued because Mary Murphy-Bessler who was our contract administrator in the Tourism Department gave her resignation and there was no replacement yet. Never once in any meeting or email or phone call, were we led to believe or notified that we would have to be vacating the Livery Stable and ending our contract 2 years prior to it expiring.
- 5) In our August 8<sup>th</sup> meeting, it was then first suggested that the City was considering not subsidizing the Stagecoach anymore. Karen Churchard was told this was our first year canceling night shifts due to safety issues, and that loss of income, minus subsidy from the City could completely put us out of business and leaving Old Town Scottsdale, The West Most Western Town, with no more Stagecoach and Carriage Rides. It was then that I stated that if we go out of business, we would give the City first right of

refusal to purchase the Stagecoach we had custom made for the City of Scottsdale. It is rare, custom made, and the last Stagecoach from here to Tombstone. In that meeting, Karen Churchard encouraged us to continue our paid rides at Brown and Main St, and led us to believe we would do that out of the Livery Stable. Never once was it mentioned or discussed having to completely vacate Old Town, until the Vacate Letter from Karen Churchard September 7<sup>th</sup>, which brought us to Petition the City for help.

- 6) Karen Churchards emails themselves state the City was indeed going to cancel subsidizing for the Stagecoach. And encouraged us to continue paid rides. Nowhere does it state, in any of her emails, that we would have to vacate all of our equipment out of Old Town.
- 7) "paid walk-up rides represent 75 to 80 percent of Scottsdale Carriage earnings" This is a FALSE statement and completely inaccurate. Now that this year we are eliminating all night shifts after sunset that previously ran until 10 and 11pm, our walk-up rides now is less than 40 percent.
- 8) "Concerned about safety and risk to the City due to a Carriage accident"??? This sentence is complete injustice and down plays our impeccable safety record for over 30 years.

The time was taken to explaine to City Staff for their Report, about our extensive horse training, safety manuals the City has on file we authored and our safety protocol that proves over 30 years insured without incident: Our Horse training determines if a horse is safe with the right disposition and temperament to be in the public venue of Old Town Scottsdale.

We live off Cactus in the corridor of Cactus Acres. Each horse we consider for Old Town Scottsdale, first must make 20 to 25 miles on a training carriage through our neighborhood on side streets before the horse is even introduced to Cactus Rd. If they make it through side streets, we have a minimum standard of 50 miles on Cactus Rd and Shea Bl, without incident, before they even make it to the outskirts of Old Town on side streets. There, they are chaperoned by 7 to 8 of our wranglers, introducing them to the Downtown Trolley, it's air brakes and horn, Fire and Police sirens that go by at random, traveling bicycle bars with loud music and people screaming, all the Segway companies, the golf carts that backfire, the pedicabs, bicycles, motorcycles and now lime bikes left in the road. scooters and skateboards.... We have had several horses that never passed our extensive training to be put in Old Town and went to better homes more suitable. The horse in the City Manager Staff report, was only one of many horses that never made it to work in the public venue of Old Town Scottsdale.

To take the time to explain our safety protocol we go through to City Management Staff, and have everything we do, be twisted and turned into one sentence judgement that we are a safety risk, is an inaccurate and misleading injustice.

9) Proposed City Ordinance for Scottsdale: This was written by Scottsdale Carriage when another carriage operator came to Old Town with no insurance and an untrained horse who ran into a City sign. After that they left and never came back. This ordinance was written from the examples of other Cities who have Carriage businesses, specifically, San Diego, Sacramento, Colorado, Texas, Oklahoma, Chicago and New York City.

Because we were and are the only Carriage Company in Scottsdale who met all the ordinance requirements and there was no other carriage operator, it never made it to City Council. We have been the ONLY Stagecoach and Carriage Business in Scottsdale for the past 12 years.

When Karen Churchard suggests that "other carriage operators may come", who bring a horse in from anywhere that is untrained in Old Town and uninsured, puts the City of Scottsdale at great risk, both putting the public at risk of physical harm or worse and the legal ramifications that would bring.

Even if we are the only Carriage Operator in Old Town Scottsdale, which we are, this ordinance should be adopted to protect the City of Scottsdale.

10) Purchase of our Stagecoach: We paid \$22k in materials to have it custom built. This did not include the cost of labor or shipping. That value as I explained to City Staff is \$30k to \$40k. We said we would give first right of refusal to purchase to the City for \$30k sales price. Not \$40k. Another inaccurate statement. For comparison, the authentic Wells Fargo Coaches are \$120k.

Conclusion: We now need the City to accommodate what it is scheduled to be taken away, if not the Livery Stable, then another place in Old Town to store our Stagecoach and Carriages, if the City wants to keep the last full service carriage business located in Scottsdale, to stay in Old Town Scottsdale.

We are no longer asking the City of Scottsdale to subsidize the Scottsdale Stagecoach and not asking the City for any City Tourism money. We have had the Horse Community of Scottsdale step up and sponsor the Scottsdale Stagecoach through December 31<sup>st</sup> 2018, and they have also committed to sponsor the Scottsdale Stagecoach through the season. It's now up the City Council and up to the City of Scottsdale to help us keep the last Stagecoach in Old Town, the "West Most Western Town".

#### ORDINANCE NO. 3915

AN ORDINANCE OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, ADDING ARTICLE IX FOR THE REGULATION OF ANIMAL DRAWN CARRIAGES TO CHAPTER 17 OF THE SCOTTSDALE REVISED CODE

BE IT ORDAINED by the Council of the City of Scottsdale as follows:

Section 1. Article IX to Chapter 17 of the Scottsdale Revised Code is hereby added:

Article IX. Animal Drawn Carriages.

Sec. 17-350. Purpose.

The purpose of this article is to promote the public safety and welfare of the community.

Sec. 17-351. Definitions.

The following words, terms and phrases, when used in this article, have the meanings ascribed to them in this article except where the context clearly indicates a different meaning.

(a) Carriage operator means any person that owns or operates a carriage company.

(b) Carriage means any trolley, stage coach, hack, hansom, or other means of transportation that is drawn by a service animal.

(c) Driver means any person who drives a carriage on the streets of the city.

(d) Service animal means any horse, mule or other beast of burden used to draw a carriage.

Sec. 17-352. Insurance.

- (a) Every carriage operator shall maintain at all times an owner's or carriage operator's policy of liability insurance in the amount of at least one million dollars.
- (b) The insurance company issuing the policy shall be authorized to issue commercial liability policies in Arizona by the Arizona Department of Insurance.
- (c) The policy shall designate by manufacturer's serial or other identification number all carriages for which coverage is granted.
- (d) The policy shall insure the person named in the policy and any other person including drivers using the carriage with the express or implied permission of the named insured against any liability arising out of the ownership, maintenance or use of the carriage in Arizona.

Sec. 17-353. Operation limitations.

Other than crossing at intersections or as part of a funeral procession, the operation of carriages is restricted to streets that have a speed limit of thirty (30) miles per hour or less.

Sec. 17-354. Operation requirements.

- (a) Carriage Equipment: Every carriage shall be maintained in a clean, sanitary and safe mechanical condition, and at all times suitable for public transportation of passengers. In addition, each carriage shall:
  - (1) Be equipped with an operational pair of red taillights, a minimum of two by four inches (2" x 4"), to be kept on during the period between sunset and sunrise;
  - (2) Be equipped with lights that will emit to the front and side, light visible from a distance of five hundred (500) feet, to be kept on during the period between sunset and sunrise;
  - (3) Have attached to the rear of the carriage a Slow Moving Vehicle reflective triangle approved by the Arizona Department of Transportation;
  - (4) Be equipped with manure-catching devices for each service animal;
  - (5) Be equipped with a carriage foot break in working order, either friction or hydraulic;

- (6) Have rate cards affixed to the carriage in a prominent location to advise prospective passengers of the rates and the name and business address of the carriage operator except if the sole use of the carriage is for funerals or weddings;
- (7) Have the carriage operator's name, address and phone number posted on the carriage so it is clearly visible; and
- (8) Have a current certificate of insurance in the carriage at all times.
- (b) Operating Regulations: Every carriage shall be driven with caution and due care for the safety of others in conformance with all applicable traffic laws, and always with the service animal(s) under complete control. In addition:
  - (1) No carriage operator or driver shall permit a service animal to pull a carriage at a speed faster than a trot, except in an emergency situation.
  - (2) Carriage operators and drivers are prohibited from leaving the carriage and service animal(s) unattended.
  - (3) Carriage operators and drivers must treat urine with a chemical deodorizing solution and remove manure from the street as soon as reasonably practicable.
  - (4) Carriage operators or drivers shall not willfully impede the normal flow of motor vehicle traffic on any city street. Carriages are required to pull immediately to the nearest curb when one or more vehicles are unable to safely pass or continue in the normal flow of traffic.
  - (5) Carriages, when in motion, shall be operated only in the right-most traffic lane on any street, except when making a left-hand turn.
  - (6) Carriage operators or drivers shall not willfully impede the normal flow of pedestrian traffic on any sidewalk or crosswalk.
  - (7) No carriage operators or drivers shall touch, remove or interfere with any sign, placard, advertisement, service animal, carriage or equipment belonging to another carriage operator.

#### (c) Treatment of Passengers:

- (1) No carriage operator or driver shall solicit patronage in any loud, rude or offensive manner, or impede the movement or follow any person for the purpose of soliciting business.
- (2) No carriage operator or driver shall charge a greater sum than the advertised rates affixed to the carriage.
- (3) No carriage operator or driver shall allow any passenger to ride on any part of the carriage while in motion except seated inside the carriage.

#### (d) Service Animal Requirements:

- (1) No carriage operator or driver shall place any service animal into service that is not fit for such service.
- (2) No service animal shall be subject to any condition or treatment which may impair the good health and physical condition of that animal.
- (3) Each service animal shall have its hooves maintained in an appropriate condition suitable for street surfaces.

#### Sec. 17-355. Violations and Penalties.

- (a) Notwithstanding any other penalties which may be imposed for failure to comply with any city, state or federal law, ordinance or regulation, it is unlawful:
  - (1) For a carriage operator or driver to fail to display proof of insurance, to a law enforcement officer on demand.
  - (2) For a carriage operator or driver to operate or drive a carriage on the city streets

in violation of any provision of this article that imposes a duty or is prohibited.

- (b) A violation of any provision of this article is a petty offense. A second offense within one year (1) is a class three (3) misdemeanor.
- (c) A Scottsdale police officer, City Manager or designee may:
  - (1) Immediately prohibit or remove from operation on city streets, any carriage that is in violation of this article.
  - (2) Prohibit or limit the operation of carriages on city streets when such operation would be inconsistent with other special events or public safety requirements.

Sec. 17-356. Exemptions; compliance with traffic laws.


- (a) The provisions of this article do not apply to carriages or their drivers that are used strictly for recreation, showing, racing or pursuant to a city issued special events permit.
- (b) Every person driving a carriage, even if exempted by this section, shall drive with caution and due care for the safety of others in conformance with all applicable traffic laws, and always with the service animals(s) under complete control.


