

RESOLUTION NO. 2209

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY GENERAL ELECTION OF MARCH 23, 1982, AND DECLARING THE ELECTION OF ONE CANDIDATE TO THE OFFICE OF COUNCILMAN
