Paths & Trails Subcommittee of the Transportation Commission provides a public forum for issues surrounding paths and trails. The Subcommittee shall consist of five (5) members. Two (2) of the members shall be Transportation Commissioners appointed by the Transportation Commission Chair. One (1) member shall be a Parks and Recreation Commissioner appointed by the Parks and Recreation Commission Chair. These three (3) members will be appointed annually. Two (2) non-commissioner members apply and are appointed by City Council for a term of three years, maximum of two terms. The Chair shall be a Transportation Commissioner selected by the Transportation Commission Chair.
