

RESOLUTION 4008

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE PRIMARY ELECTION OF FEBRUARY 15, 1994, DECLARING THE ELECTION OF TWO CANDIDATES FOR TWO CITY COUNCIL OFFICES AND THE NOMINATION OF TWO CANDIDATES FOR ONE CITY COUNCIL OFFICE.

WHEREAS, a primary election of the City of Scottsdale, Arizona was held on February 15, 1994, pursuant to the city charter and the laws of the State of Arizona, for the purpose of electing three (3) councilmen; and

WHEREAS, the council of the City of Scottsdale, having canvassed the returns of the primary election and finding such returns to be as stated below and in the exhibits to this resolution, which are attached and incorporated by reference.

NOW, THEREFORE, let it be resolved by the council of the City of Scottsdale, Maricopa County, Arizona, as follows:

Section 1. The results of the canvass having been determined, the official canvass of the primary election is declared to be as shown in the cumulative report of the primary election ("Cumulative Report") which is attached as Exhibit "A" and which is hereby incorporated by this reference, and the district reports by district ("District Report") which are attached as a group in Exhibit "B", and which are hereby incorporated by this reference. The Cumulative Report and District Reports shall be the basis for the results stated below.

Section 2. The total number of ballots cast at said primary election as shown by the poll lists, was 9,114.

Section 3. The votes cast for the candidates for council member were as follows:

Section 5. It is hereby found, determined and declared of record, that the following two candidates did receive more than one-half of the total number of valid votes cast and are hereby issued certificates of election:





RESOLUCION 4008

RESOLUCION DEL CONCEJO DE LA CIUDAD DE SCOTTSDALE, CONDADO MARICOPA, ARIZONA, DECLARANDO EL EXAMEN OFICIAL DE VOTOS EMITIDOS EN LA ELECCION PRIMARIA DE LA CIUDAD DE SCOTTSDALE DEL 15 DE FEBRERO DE 1994, DECLARANDO QUE DOS CANDIDATOS FUERON ELECTOS PARA DOS PUESTOS DE CONCEJALES DE LA CIUDAD, Y EL NOMBRAMIENTO DE DOS CANDIDATOS PARA UN PUESTO DE CONCEJAL DE LA CIUDAD.

**POR CUANTO**, una elección primaria de la Ciudad de Scottsdale, Arizona, tuvo lugar el 15 de febrero de 1994, de acuerdo con la carta constitucional de la Ciudad y las leyes del Estado de Arizona, con el propósito de elegir a tres (3) concejales; y

**POR CUANTO**, el Concejo de la Ciudad de Scottsdale, habiendo examinado los resultados de la elección primaria, y habiendo verificado que dichos resultados fueron según se indica en seguida y en las Pruebas Documentales de esta resolución las cuales por referencia se adjuntan y se incorporan a la presente.




