

**RESOLUTION NO. 6463**

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE GENERAL ELECTION HELD MARCH 9, 2004; DECLARING THE ELECTION OF ONE CANDIDATE FOR THE OFFICE OF CITY COUNCIL MEMBER; AND DECLARING TWO CANDIDATES FOR THE OFFICE OF MAYOR AND SIX CANDIDATES FOR THE OFFICE OF CITY COUNCIL MEMBER IN THE RUNOFF ELECTION TO BE HELD MAY 18, 2004; AND DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN A SPECIAL ELECTION, HELD CONCURRENTLY WITH THE GENERAL ELECTION, ON TWO PROPOSITIONS VOTED UPON BY THE QUALIFIED ELECTORS OF THE CITY.

WHEREAS, the City of Scottsdale, Maricopa County, Arizona, held a General Election on March 9, 2004, pursuant to Article 9, Section 1 of the Scottsdale City Charter, for the purpose of electing a mayor and four council members for the City of Scottsdale; and

WHEREAS, a Special Election was also held on March 9, 2004, at the same time as the General Election, for the purpose of presenting Proposition 100 and Proposition 300 to the qualified electors of the City; and

WHEREAS, Proposition 100, proposed and submitted to the people by the City Council, would have amended the Scottsdale City Charter to change the current form of government from an at-large to a six-district system, with the Mayor being elected at large; and

WHEREAS, Proposition 300, a referendum ordered by petition of the people, allowed the voters to approve or reject the City Council's adoption of Resolution No. 6324 that authorized a redevelopment agreement between the City and Los Arcos Development LLC for a proposed project on property generally located south and east of the intersection of McDowell Road and Scottsdale Road (formerly Los Arcos Mall); and

WHEREAS, ARS 16-642 requires that the City Council canvass the returns of the election no later than fifteen (15) days following the election; and

WHEREAS, the Council of the City of Scottsdale, having canvassed the returns of the General Election and the Special Election, find the returns to be as stated in this resolution,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Scottsdale as follows:

1. The results of the canvass having been determined, the official canvass of the City of Scottsdale General Election and Special Election held on March 9, 2004 is as follows:
  - a) A summary of the number of votes cast in each district for each candidate for the offices of mayor and council member and the two propositions is shown on Exhibit A, which is attached and incorporated by this reference.
  - b) A precinct group detail of the number of ballots cast by district is shown on Exhibit A, which is attached and incorporated by this reference.
3. The following named candidates for the office of mayor, having received the greatest number of votes cast in the General Election, which number was less than the majority of all votes cast, will be candidates for the office of mayor at the Runoff Election, to be held on May 18, 2004:

Mary Manross  
David Ortega
4. Betty Drake, having received more than a majority of the votes cast at the General Election for the office of council member, is declared to be elected to that office.
5. The following named candidates, having received the greatest number of votes cast in the General Election, which number was less than the majority of all votes cast, will be candidates at the Runoff Election, to be held on May 18, 2004, for three council seats to be filled:

Jim Lane

6. Proposition 100, which received a number of votes that was less than a majority of the votes cast, was rejected by the qualified electors.
7. Proposition 300, which received a number of votes that was less than a majority of the votes cast, was rejected by the qualified electors.







## RESOLUCIÓN NÚM. 6463

UNA RESOLUCIÓN DEL CONCEJO DE LA CIUDAD DE SCOTTSDALE, CONDADO DE MARICOPA, ARIZONA DECLARANDO EL ESCRUTINIO OFICIAL DE LOS VOTOS EMITIDOS EN LA ELECCIÓN GENERAL DE LA CIUDAD DE SCOTTSDALE QUE SE CELEBRÓ EL 9 DE MARZO DE 2004; Y DECLARANDO QUE DOS CANDIDATOS PARA EL PUESTO DE ALCALDE Y SEIS CANDIDATOS PARA EL PUESTO DE MIEMBRO DEL CONCEJO DE LA CIUDAD SE PRESENTARÁN EN LA ELECCIÓN QUE SE CELEBRARÁ EL 18 DE MAYO DE 2004; Y DECLARANDO EL ESCRUTINIO OFICIAL DE LOS VOTOS EMITIDOS EN UNA ELECCIÓN ESPECIAL QUE SE CELEBRÓ JUNTO CON LA ELECCIÓN GENERAL DE DOS PROPOSICIONES SOBRE CUALES VOTARON LOS ELECTORES CAPACITADOS DE LA CIUDAD.

VISTO QUE, el 9 de mayo de 2004 se celebró una Elección General de la Ciudad de Scottsdale, Condado de Maricopa, Arizona, de acuerdo con el Artículo 9, Sección 1 de la Carta Constitucional de la Ciudad de Scottsdale, con el propósito de elegir un alcalde y cuatro miembros del concejo para la Ciudad de Scottsdale; y

VISTO QUE, el 9 de marzo de 2004 también se celebró una Elección Especial, junto con la Elección General, con el propósito de presentarles a los electores capacitados de la Ciudad la Proposición 100 y la Proposición 300; y

VISTO QUE, la Proposición 100 propuesta y que se le presentó a la gente por el Concejo de la Ciudad, enmienda la Carta Constitucional de la Ciudad Scottsdale cambiando la forma de gobierno actual de un sistema de gobierno elegido en general a un sistema de seis distritos, con el Alcalde elegido en general; y

VISTO QUE, la Proposición 300, un referéndum ordenado a petición de la gente permite a los votantes aprobar o rechazar la adopción de la Resolución Núm. 6324 por el Concejo de la Ciudad que autoriza un acuerdo de re-urbanización entre la Ciudad y Los Arcos Development LLC para un proyecto propuesto en la propiedad ubicada generalmente al sureste de las calles McDowell Road y Scottsdale Road (anteriormente Los Arcos Mall);

VISTO QUE, los Estatutos Revisados de Arizona 16-642 ordenan que el Concejo de la Ciudad complete el escrutinio de los resultados de la elección no más tarde que quince (15) días después de la elección; y

VISTO QUE, el Concejo de la Ciudad de Scottsdale, habiendo completado el escrutinio de los resultados de la Elección General y la Elección Especial, encuentra los resultados ser como se declaran en esta resolución.

AHORA, POR CONSIGUIENTE, RESUELVE el Concejo de la Ciudad de Scottsdale como lo que sigue:

1. Los resultaos del escrutinio se han determinado, el escrutinio oficial de la Elección General y la Elección Especial de la Ciudad de Scottsdale que se celebró el 9 de marzo de 2004 son como lo que sigue:

2. 


