Councilman Robbins moved to approve Consent Items 1 through 13, absent Item 4.  
Councilmember Korte seconded the motion, which carried 7/0.

## **REGULAR AGENDA**

Acting City Manager Dan Worth and City Treasurer David Smith gave PowerPoint presentations (attached) on the proposed FY 2013/14 budget.

Mayor Lane opened public testimony.

Mayor Lane closed public testimony.

Community Services Executive Director Bill Murphy gave a PowerPoint presentation (attached) on the Scottsdale Cares Program. Mr. Murphy explained that the annual amount the City pays Tempe Community Action Agency (TCAA) for meals for Scottsdale seniors is \$58,970. He reported that the Industrial Development Authority has granted \$33,970 to the program, which, together with a \$25,000 donation from a Scottsdale citizen, will fund the Meals-on-Wheels Program for FY 2013/14. Mr. Murphy assured the Council that the City will take the steps necessary to ensure the program remains a community priority.

Acting City Manager Dan Worth gave a PowerPoint presentation (attached) on the impacts that transitioning six full time employees from the Court Enhancement Fund into the General Fund would have on the Court Enhancement Fund's growth.

Mr. Worth gave a PowerPoint presentation (attached) on attrition trends and strategies for the Police Department.

Discussion:

- A Councilmember expressed support for the step pay plan proposed by POSA, arguing that police officers should be paid on a different scale than other City employees.
- A Councilmember suggested earmarking money in the budget for police officer salaries, pending Council review of salary and retention statistics from competing cities.

### **MOTION NO. 1 - ITEM 14**

Councilman Littlefield moved to direct staff to develop a step program and incorporate it into the proposed budget. Councilmember Phillips seconded the motion. No vote taken.

Discussion:

- Police Chief Alan Rodbell explained that the old pay system gave 5% increases from the time an officer joined the department until they maxed out. He believes POSA's proposal is an attempt to recover wage increases that were not given during a four-year period when the 5% system was not in place.
- A Councilmember suggested giving Chief Rodbell \$2.5M out of one-time funds to be used at his discretion to resolve salary issues within the Police Department.
- Mr. Worth explained that the 2% for salary adjustments in the proposed budget is intended to be a short-term solution. If revenues improve as forecasted, salary increases should resume at 3% or 4% on a regular basis by FY 2014/15 or FY 2015/16. If the Council's direction is to spend \$2.5M at one time, Mr. Worth and Chief Rodbell will discuss the best way to distribute the funds. Mr. Worth suggested the possibility of giving bonuses instead of pay increases.

## **ALTERNATE MOTION - ITEM 14**

Councilwoman Milhaven made an alternate motion to direct staff to: (1) increase the proposed budget by \$2.5M in one-time monies to address potential salary inequities; and (2) prior to spending any funds, complete a competitive salary survey and a proposal on how the monies would be spent and bring the proposal back to Council for approval no later than September. Councilmember Korte seconded the motion, which carried 5/2, with Councilmembers Littlefield and Phillips dissenting.

Mr. Worth gave a PowerPoint presentation (attached) on the Fire Department's standards of coverage and the issues related to coverage for Station 602's response area. Mr. Worth outlined two options for staffing Station 602: (1) continue with staffing at the existing level, using overtime, at an approximate cost of \$425,000 from one-time funds; or (2) add eight additional full-time firefighters at an initial cost of approximately \$600,000.

## **MOTION NO. 2 - ITEM 14**

Councilman Littlefield moved to direct staff to increase the proposed budget by \$575,000 in one-time monies to staff Fire Station 602 up to the level needed for two companies. Councilwoman Milhaven seconded the motion.

### Discussion:

- City Treasurer David Smith expressed concern about using one-time monies for ongoing expenditures.
- A Councilmember expressed support for adding a company to Fire Station 602, but believes it should be postponed until resources are identified to permanently cover the cost.

## **ALTERNATE MOTION AND VOTE - ITEM 14**

Councilman Robbins made an alternate motion to direct staff to add \$425,000 in one-time monies to the Fire Department's proposed overtime budget to return Fire Station 602's staffing to FY 2011/12 levels. Mayor Lane seconded the motion, which failed 3/4, with Councilmembers Korte, Littlefield, Milhaven, and Phillips dissenting.

In response to a question on how a new fire company at Station 602 would be funded, Mr. Worth explained that the money would come from the unreserved fund balance initially and would be included as part of the base budget for FY 2014/15.

## **VOTE ON MOTION NO. 2 - ITEM 14**

The Council vote on the motion to direct staff to increase the proposed budget by \$575,000 in one-time monies to staff Fire Station 602 up to the level needed for two companies carried 5/2, with Mayor Lane and Councilman Robbins dissenting.

Fire Marshal Jim Ford gave a PowerPoint presentation (attached) on the Fire Department's request for a Deputy Fire Marshal. He explained that the Fire Department was able to eliminate positions during the FY 2009/10 time period because there was less construction. When the economy began to recover, the need for service drastically increased. The return of the Deputy Fire Marshal position will allow for an additional 800 inspections a year, including high hazard occupancy inspections.

Mr. Worth suggested that the Fire Marshal position could be funded out of one-time monies or exchanged for the Public Works Information Technology Human Resources position. Mr. Worth confirmed that if the position was added to the proposed budget, it could be funded by savings that are anticipated to accumulate throughout the year.

### **MOTION NO. 3 AND VOTE - ITEM 14**

Vice Mayor Klapp moved to direct staff to add \$110,406 to the proposed budget to fund a Deputy Fire Marshal position. Councilwoman Milhaven seconded the motion, which carried 5/2, with Mayor Lane and Councilman Robbins dissenting.

Acting Public Works Executive Director Derek Earle gave a PowerPoint presentation (attached) on requests made by Council during the April 16th meeting, which included the Public Art Entry Feature at Marshall Way off of Indian School Road; Scottsdale Stadium improvements; WestWorld improvements; and CIP General Fund cash flow coverage.

### **MOTION NO. 4 - ITEM 14**

Councilmember Korte moved to direct staff to remove the \$4.3M WestWorld renovation project from the CIP Program. Councilwoman Milhaven seconded the motion.

Discussion:

- Mr. Earle explained that removing the WestWorld project will have negative impacts on current shows, but it would not prevent the shows from being held. He confirmed that operational adjustments could be made to assist with proper setup.
- A Councilmember stressed the importance of maintaining WestWorld at a superior level because the venue hosts most of the City's economic and tourist generating events.
- A Councilmember commented the City should not continue pouring money into WestWorld without a business or marketing plan that justifies the expenditure.

### **VOTE ON MOTION NO. 4 - ITEM 14**

The Council vote on the motion to direct staff to remove the \$4.3M WestWorld renovation project from the CIP Program failed 2/5, with Mayor Lane; Vice Mayor Klapp; and Councilmembers Littlefield, Phillips, and Robbins dissenting.

### **MOTION AND VOTE - ITEMS 15, 16, AND 17**

Councilman Littlefield moved to continue Items 15, 16, and 17 to May 14, 2013. Councilwoman Milhaven seconded the motion, which carried 7/0.

**18. Citizen Petition Requesting Consideration of the Determination Regarding the Blue Sky Stipulation**

**Request:** Discuss, consider, and provide possible direction to staff on a citizen petition, as provided by the City Charter, seeking consideration of the Acting City Manager's determination that Blue Sky had complied with its conditional zoning stipulation.

Acting City Manager Dan Worth provided an overview of the Blue Sky project conditional zoning stipulation. He explained that after the project passed inspection with Building Services, in his capacity as Acting City Manager, he determined that the stipulation had been met. A citizen petition requesting consideration of his determination was submitted on April 9, 2013.

Mayor Lane opened public testimony.

Mayor Lane closed public testimony.

### **MOTION NO. 1 - ITEM 18**

Councilman Littlefield moved to affirm that the Blue Sky zoning stipulation has not been met. Councilman Phillips seconded the motion.

Discussion:

- In response to a question of order, City Attorney Bruce Washburn confirmed that the motion was in order.
- A Councilmember noted that the stipulations require the property owner to commit a minimum of 25% of the cost of construction for enhanced pedestrian crossing improvements from the subject property to the north side of Scottsdale Road adjacent to Fashion Square Mall. Additionally, each of the 38 easements for the site must be conveyed by final plat prior to the issuance of a building permit. Because these stipulations were not met, the Councilmember believes the building permit was issued illegally.
- Mr. Washburn stressed that whatever decisions are made must be based on relevant facts. He urged the Council to refrain from acting until all of the facts have been fully vetted.

### **VOTE ON MOTION NO. 1 - ITEM 18**

The Council vote on the motion to affirm that the Blue Sky zoning stipulation has not been met failed 2/5, with Mayor Lane; Vice Mayor Klapp; and Councilmembers Korte, Milhaven, and Robbins dissenting.

### **MOTION NO. 2 - ITEM 18**

Mayor Lane moved to take no action on the citizen petition seeking consideration of the Acting City Manager's determination that Blue Sky had complied with its conditional zoning stipulation. Councilwoman Milhaven seconded the motion.

### **ALTERNATE MOTION - ITEM 18**

Councilman Phillips made an alternate motion to direct staff to proceed with the continuance of the item for a maximum of 120 days, until such time as the traffic and safety issues have been resolved to all concerned, including, but not limited to, the revised building heights and density, additional ingress and egress, and the guest parking. After the 120 days extension, staff can present their findings to the Council for approval of the new site plan and a two-year continuance. Councilman Littlefield seconded the motion and later withdrew it. Motion died for lack of a second.

## **ALTERNATE MOTION - ITEM 18**

Councilman Littlefield made an alternate motion to continue the item until the City Manager reports back to the Council on whether the Blue Sky zoning stipulations, as they relate to the issuance of the building permit, have been met. Councilman Phillips seconded the motion, which failed 2/5, with Mayor Lane; Vice Mayor Klapp; and Councilmembers Korte, Milhaven, and Robbins dissenting.

## **VOTE ON MOTION NO. 2 - ITEM 18**

The Council vote on the motion to take no action on the citizen petition seeking consideration of the Acting City Manager's determination that Blue Sky had complied with its conditional zoning stipulation carried 5/2, with Councilmembers Littlefield and Phillips dissenting.

Acting City Manager Dan Worth committed to researching the Blue Sky zoning stipulations, as they relate to the issuance of the building permit, and report back to the Council.

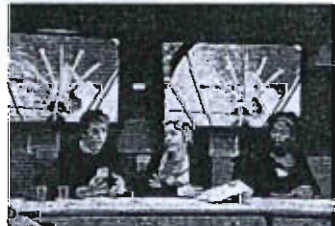

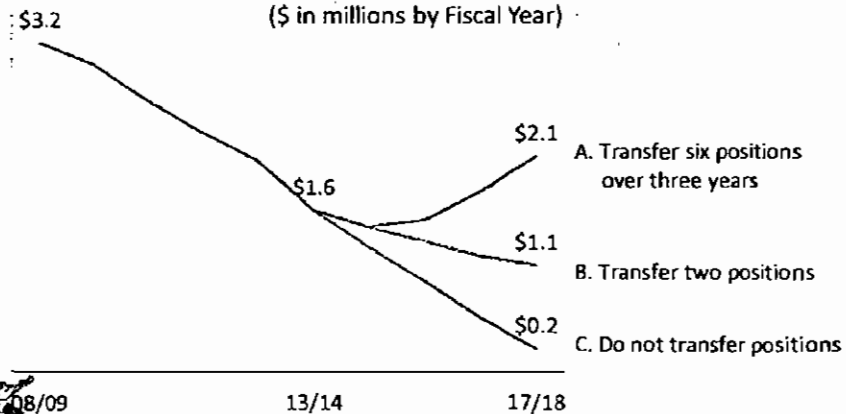

(\$ in millions by Fiscal Year)

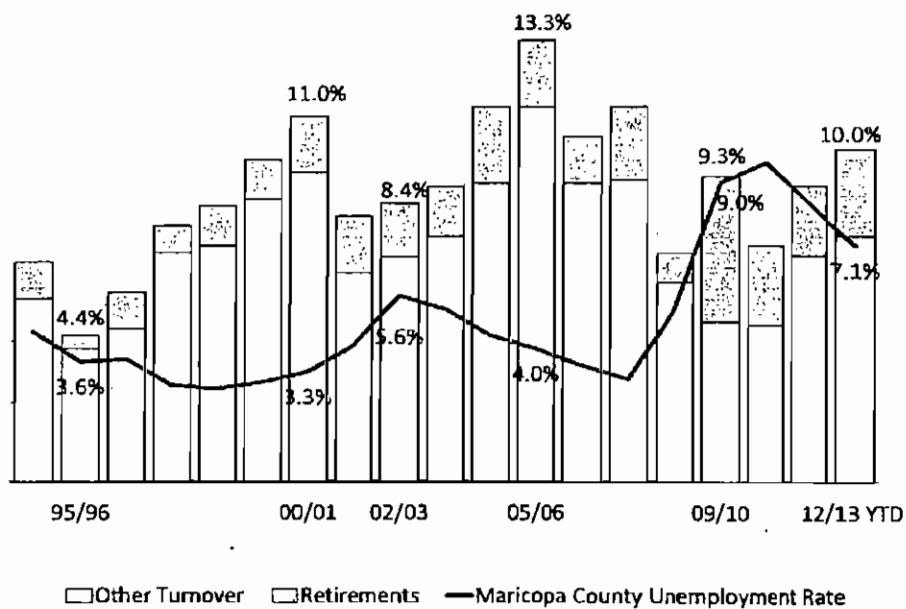


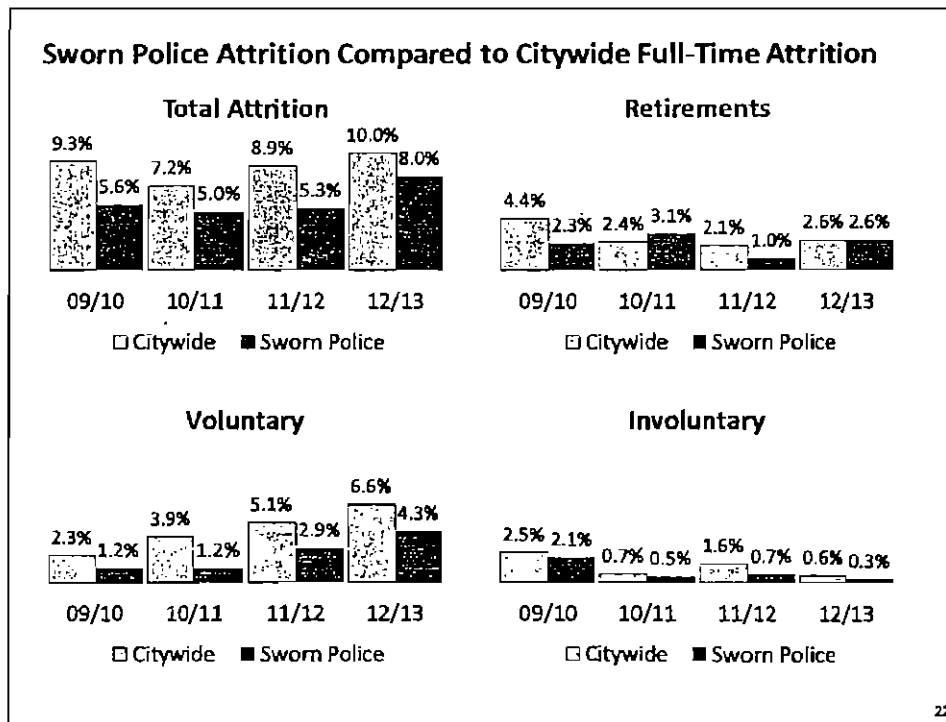
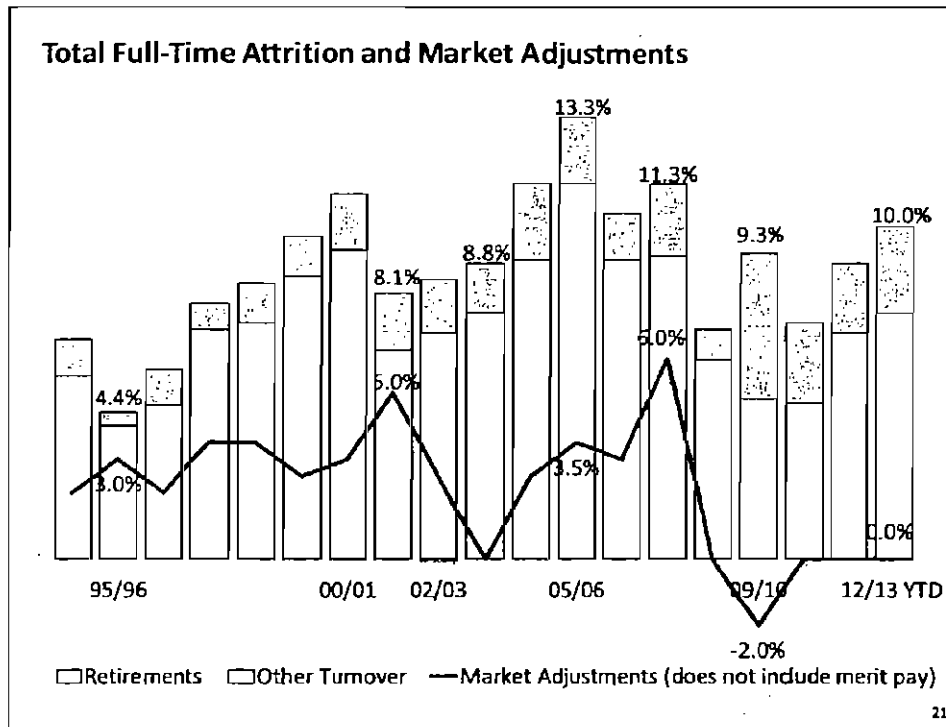

### Total Full-Time Attrition and Unemployment



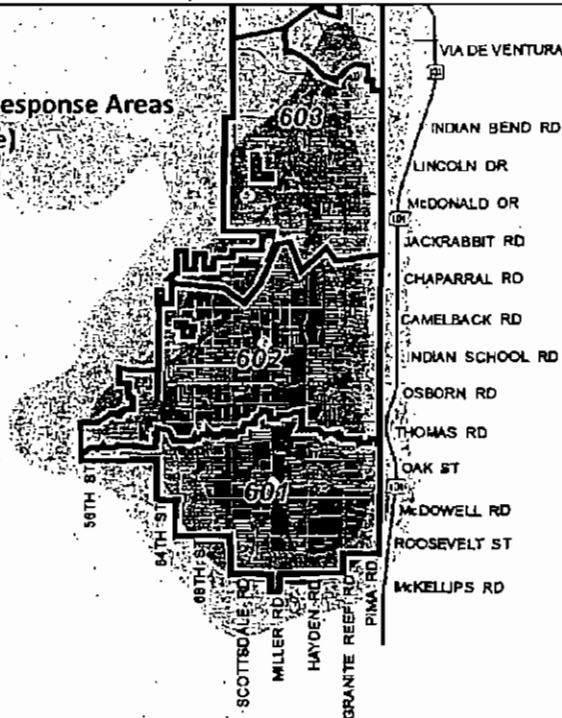




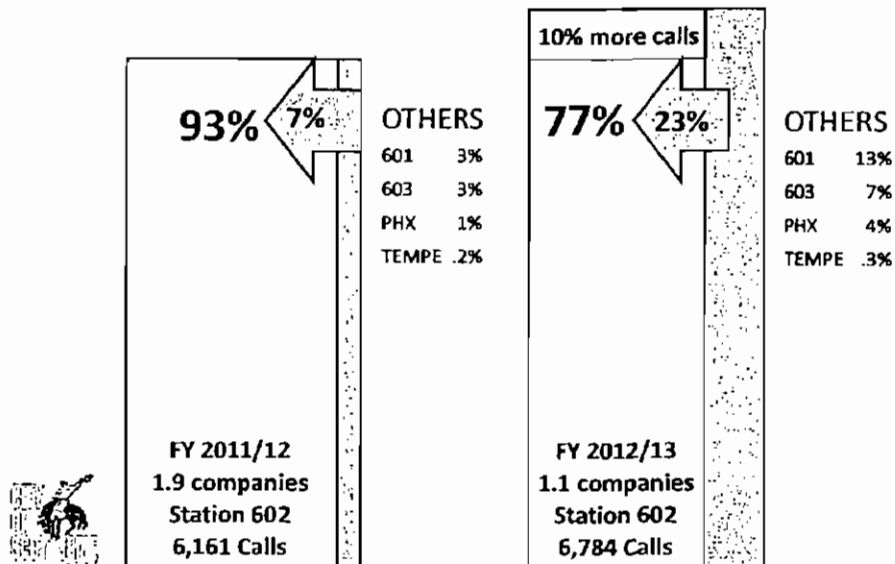

- Agendize a City Council hearing on this project to allow citizens' presentations of alternatives to the currently proposed design. The homeowners' goal is to eliminate the negative impacts on our Scottsdale residential properties and to make this a better and less costly project.
- Hold this City Council hearing after the summer break and during Fall 2013 to include community input from the many impacted families who are out of town during the summer months.
- Direct city staff to not submit this project to the Transportation Commission or the Development Review Board until after the City Council public hearing on this project has been held.
