

RESOLUTION NO. 4016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE GENERAL ELECTION OF MARCH 22, 1994, AND DECLARING THE ELECTION OF ONE (1) CANDIDATE FOR THE OFFICE OF COUNCILMAN.

WHEREAS, a general election of the City of Scottsdale, Arizona, was held on Tuesday, March 22, 1994, pursuant to the city charter and the laws of the State of Arizona, for the purpose of electing one councilman; and

WHEREAS, the council of the City of Scottsdale, having canvassed the returns of the general election and finding such returns to be as stated below and in the exhibits to this resolution, which are attached and incorporated by reference.

NOW, THEREFORE, BE IT RESOLVED by the council of the City of Scottsdale as follows:

Section 1. The results of the canvass having been determined, the official canvass of the City of Scottsdale general election of March 22, 1994, is declared to be as shown in the cumulative report of the general election ("Cumulative Report") which is attached as Exhibit "A" and which is hereby incorporated by this reference, and the district reports by district ("District Report") which are attached as a group in Exhibit "B", and which are hereby incorporated by this reference. The Cumulative Report and District Reports shall be the basis for the results stated below.

Section 2. The total number of ballots cast at said primary election as shown by the poll lists, was 6,121.

Section 3. The votes cast for the candidates for council member were as follows:





RESOLUCION NO. 4016

RESOLUCION DEL CONCEJO DE LA CIUDAD DE SCOTTSDALE, CONDADO DE MARICOPA, ARIZONA, DECLARANDO EL EXAMEN OFICIAL DE VOTOS EMITIDOS EN LA ELECCION GENERAL DE LA CIUDAD DE SCOTTSDALE QUE TUVO LUGAR EL 22 DE MARZO DE 1994, Y DECLARANDO QUE FUE ELEGIDO UN (1) CANDIDATO PARA EL PUESTO DE CONCEJAL.

POR CUANTO, una elección general de la Ciudad de Scottsdale, Arizona, se llevó a cabo el martes, 22 de marzo de 1994, de acuerdo con la carta constitucional de la ciudad y las leyes del Estado de Arizona, con el propósito de elegir a un concejal; y


