ACTION

Adopt Resolution No. 12478, approving Contract No. 2017-002-COS-A1, an amendment to Contract No. 2017-002-COS, between the City of Scottsdale and the Arizona Quarter Horse Association to broaden the description of horse shows allowed for their events.

BACKGROUND

The Arizona Quarter Horse Association (AzQHA) has produced the AZ Sun Country Circuit Quarter Horse Show at WestWorld since 1988. The Sun Circuit is the longest running show at WestWorld and is one of the largest quarter horse circuits in the nation.

On January 17, 2017, the City Council authorized Contract No. 2017-002-COS between WestWorld, the City of Scottsdale and the AzQHA to produce the event in March of year which includes the Parada del Sol Rodeo, a Professional Rodeo Cowboys Association event and the Fall Championship Show. The term of Contract No. 2017-002-COS is through 2025.

The Arizona Quarter Horse Association would like to expand the type of horse show they produce from solely producing a Quarter Horse Breed Show to include stock horse/stock discipline.



RESOLUTION NO. 12478

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY ARIZONA APPROVING AN AMENDMENT TO THE CONTRACT BETWEEN THE CITY AND THE ARIZONA QUARTER HORSE ASSOCIATION REGARDING THE ARIZONA SUN COUNTRY CIRCUIT QUARTER HORSE SHOW.

WHEREAS, the City entered into a multi-year agreement with the Arizona Quarter Horse Association to hold the Arizona Sun Country Quarter Horse Show at WestWorld, which also includes the Fall Championship Show and the Parada del Sol Rodeo; and

WHEREAS, parties would like to amend the contract to broaden the event from a quarter horse breed show to include stock horse/stock discipline.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Scottsdale, Maricopa County, Arizona as follows:

Section 1. The Mayor is hereby authorized and directed to execute the amendment to the contract between the City and the Arizona Quarter Horse Association, Contract No. 2017-002-COS-A1.



FIRST AMENDMENT TO WESTWORLD EVENT AGREEMENT

THIS FIRST AMENDMENT TO WESTWORLD EVENT AGREEMENT (the "Agreement") is made and entered into this ____ day of _____, 2022, by and between City of Scottsdale, an Arizona municipal corporation ("Operator"), and the Arizona Quarter Horse Association, an Arizona nonprofit corporation ("Producer").

RECITALS

WHEREAS, Operator and Producer entered into an Agreement (the "Agreement") dated October 1, 2016 that governs the Arizona Sun Country Quarter Horse Circuit and Arizona Fall Championship (the "Event").

WHEREAS, the parties wish to amend the Agreement to allow Producer to feature additional horse breeds and disciplines in the Event.

NOW THEREFORE, in consideration of the foregoing, the Parties agree to this amendment as follows:

Paragraph (G)(1) of the Recitals is amended to read:

1. Stock horse and/or stock discipline show.

All other terms and conditions of the Agreement remain unchanged and in full force and effect.




