I am a long-time resident of the 52nd sreet/Sweetwater area. My home lies directly under one of the arrival/departure radials, and very near one of the racetrack flightpaths used by "touch and go" aircraft. I only occasionally feel that aircraft make excessive noise. Generally when being "run-up" at the far SW runway terminus, especially during cool, damp weather. (seldom a problem here)

I have absolutely no problem with military fixed-wing or rotary wing usage, as they seldom approach scottsdale unless they have a problem. My experience says that the older HUIE and Cobra gunships have the highest sound levels. They are distinct due to their wide, 2-blade rotor design. Most more modern rotary designs are inherently "stealthy", in that they sneak up on you, then quickly fade away.

The only private aircraft which draw my attention are the very loud(when low) Lear aircraft, and the one GIII gulfstream aircraft. Perhaps my attention is drawn to this aircraft due to it's size, but the pilot seems to consistently choose a departure with a short-radius turn to the nortwest, when having taken off to the SW.

We have lived at our current address, 10195 e. whispering wind dr. for three and one half years. During this period we have experienced increasing incidents of low flying aircraft, mostly private jets but also a growing number of helicopters. Several of the private jets are very noisy. In fact, the noise from some of these small jets rival noise levels generated by much larger jets, such as commercial aircraft. We are also very concerned over the growing number of commuter flights recently announced.

The noise these aircraft generate is a nuisance that we did not anticipate when we purchased our property and built a home.

After reading the findings contained in your report I do not understand why we are experiencing more, rather than fewer incidents of noisy, low flying aircraft.

Obviously we encourage implementation of any and all restrictions that would lessen the detrimental effect these aircraft are having on the environment North and East of the Scottsdale Airport. . . . .

-The basis for using the FAA DNL for noise measurement is flawed. Noise level should be based on: 1.) the total number of occurances above an acceptable level in a specific time period, 2.) the degree above the acceptable level, 3.) the duration of the noise.

- Departure on 21 should not be to 300 degrees as soon as possible, but rather south along Scottsdale Road until an acceptable altitude is reached, then west along Cactus Road.

- All departures should climb immediately to a minimum height that will minimize noise at takeoff.

Yes, Jets make a lot of noise but "most" (other than the "run-ups) of them appear to follow the restricted hours between 10:00-6:00 am. I have lived at my current address, 6211 E. Cortez Dr. since 1995. For the last few years we have seen and heard a huge increase of planes flying over our home at far less than 1 thousand feet high. These are the largest and loudest private jets flying at odd hours at times such as 2 or 4 o'clock in the morning. For example, there was a plane flying incredibly low and was extremely loud at 3:26 AM on May 2nd. This is very annoying and we are not only concerned about the horrendous noise but also for the safety of the young, elementary school children next door, at Sequoia which is on the path of the planes as well as the power lines right next to the school. When I mentioned this to the representative at the Scottsdale Airport, they had no other response than to claim that the airport was there first. Last year, someone from your Kansas office came and installed a noise reading instrument in our yard in order to measure the intensity of the noise.

However, miraculously, while the instrument was in my backyard, there were hardly any planes flying overhead. This has always been a residential community and the Scottsdale Airport was supposed to be a touch and go runway for recreational, small propeller planes. This is getting out of hand and affecting the life of tens of thousands of people living in this area. I would like the proper authorities to control the Scottsdale Airport flights and be able to route them around residential areas which I have been told is possible (precedent being, the Ironwood community in Scottsdale, which has not been affected as much as we have been). It is absolutely abnormal for the airport officials to claim that they cannot restrict hours of operation and have no control over the approach over our neighborhood and neither any way to monitor the approaches. The Scottsdale Airport claims that they do not have the proper radar to allow such monitoring. The FAA should not allow the airport to function if they do not have adequate services. In the meantime, I, a resident of Scottsdale, am suffering from the Scottsdale Airport's negligence to not accommodate their neighbors. I hope you will be of help and thank you for your cooperation.
