To whom it may concern:

On January 27, 2017 the Laboratory Manager and the Quality Manager were made aware of a complaint by the Scottsdale City Prosecutor's Office regarding the testimony of a staff member. Initially this was thought to be a performance issue only; however, during the investigation of the complaint there arose a question of the staff member's integrity based on the review of their testimony. Our laboratory is notifying ASCLD/LAB per the program overview, Section 4.6, which states:

Any significant event or significant nonconformity related to an accreditation requirement for which there is a reasonable expectation that knowledge of the event or nonconformity by interested parties external to the forensic service provider would call into question the quality of the forensic service provider's work or the integrity of its personnel must be disclosed within thirty (30) calendar days upon the director or quality manager recognizing it as significant.

At this time, the examiner has been removed from casework, interviews, and testimony. The investigation into the complaint has been turned over to the Scottsdale Police Department's Internal Affairs Unit. The IA unit will determine if the allegations are sustained. The City Prosecutor's Office has been made aware of the investigation status.

Any further actions taken by the laboratory will be dependent on the outcome of the IA investigation.

Blood Alcohol Testimony Performance Investigation-CLOSED

The investigation into the testimony of Amy Langan from 1/24/2017 was turned over to the Internal Affairs Unit of the Scottsdale Police Department. A final copy of the investigation was not given to the laboratory to maintain, however, the laboratory is aware of the results and findings issued by IA. The IA investigation sustained the complaint of failure to perform job duties and lack of professionalism. The complaint regarding integrity was unsustained. A remedial training plan was in the process of being made, beginning with a mock court on the case in question scheduled for 3/17/17. On the morning of 3/17/17 Amy Langan resigned. This investigation and all remediation by the laboratory are closed.
