# **PROPOSITION 100**

### OFFICIAL TITLE

SHALL ARTICLE 1, SECTION 3, RELATING TO POWERS OF THE CITY BE AMENDED BY ADDING NEW PARAGRAPH K.

#### DESCRIPTIVE TITLE

This proposition, if adopted, would establish the City's authority to control the collection and disposition of trash, garbage and solid waste in the City and would further authorize the City to participate in recovering anything of value from such refuse.

#### PROPOSITION 100

Shall the amendment to the Charter of the City of Scottsdale providing for control of solid waste be adopted?

A "Yes" vote shall have the effect of clarifying the authority of the City to control solid waste.

A "No" vote shall have the effect of leaving the City's authority to control solid waste unclarified.

# **PROPOSITION 101**

## OFFICIAL TITLE

SHALL ARTICLE 6, SECTION 11 RELATING TO FINANCE AND TAXATION, AND TRANSFER OF APPROPRIATIONS BE AMENDED.

#### DESCRIPTIVE TITLE

This proposition grants authority to the City Manager with specific City Council approval to transfer budget appropriations or portions thereof between departments at any time during a fiscal year.

#### PROPOSITION 101

Shall the amendment to the Charter of the City of Scottsdale providing authority to transfer appropriations be adopted?

A "Yes" vote shall have the effect of allowing the transfer of any budget appropriation from one City office, agency or department to another at any time during the fiscal year.

A "No" vote shall have the effect of limiting departmental transfers to the last three months of each fiscal year.

### PROPOSITION 102

# SFFICIAL TITLE

SHALL ARTICLE 6 RELATING TO FINANCE AND TAXATION BE AMENDED BY ADDING A NEW SECTION 16.

#### DESCRIPTIVE TITLE

This proposition, pursuant to Article IX, Sec. 20 (3) (d) (viii), Arizona Constitution, allows the City to exclude from the State imposed spending limit expenditures for any capital improvements and land therefor, including streets, parks, sewer systems, water systems, airport, and all other capital improvements.

#### PROPOSITION 102

Shall the amendment to the Charter of the City of Scottsdale excluding expenditures for capital improvements from State expenditure limitations be adopted?

A "Yes" vote shall have the effect of permitting local (City Council) control over expenditures for capital improvements.

A "No" vote shall have the effect of including capital improvement expenditures in the State imposed expenditure limitation, regardless of the availability of funds and local needs.

#### **PROPOSITION 103**

Shall the amendment to the Charter of the City of Scottsdale providing for competitive bidding on City improvement contracts when required by law be adopted?

A "Yes" vote shall have the effect of requiring competitive bidding when required by State law. A "No" vote shall have the effect of retaining the present Charter requirement that all City improvement contracts in excess of Five Thousand Dollars (\$5,000.) be awarded after competitive bidding, and would bind the City Council to such figure notwithstanding changes in the State law permitting award of such contracts without competitive bidding.

### **PROPOSITION 104**



### OFFICIAL TITLE

SHALL ARTICLE 8, SECTION 3 RELATING TO PURCHASES BE AMENDED.

#### DESCRIPTIVE TITLE

This proposition increases the City Manager's purchasing authority from a maximum of Five Thousand Dollars (\$5,000.) to a maximum of Fifteen Thousand Dollars (\$15,000.) without formal competitive bidding and approval by the Council.

#### PROPOSITION 104

Shall the amendment to the Charter of the City of Scottsdale providing an increase in the City Manager's purchasing authority be adopted?

A "Yes" vote shall have the effect of increasing the City Manager's authority from Five Thousand Dollars (\$5,000.) to Fifteen Thousand Dollars (\$15,000.) without formal competitive bidding. A "No" vote shall have the effect of retaining the City Manager's present purchasing authority up to a maximum of Five Thousand Dollars (\$5,000.).

# OFFICIAL TITLE

SHALL ARTICLE 10, SECTION 1 RELATING TO INITIATIVE, REFERENDUM AND RECALL BE AMENDED.

### DESCRIPTIVE TITLE



This proposition grants authority to the City Council to refer an ordinance to the voters on its own motion with the same effect as ordinances referred by petition of the voters.

#### PROPOSITION 105

Shall the amendment to the Charter of the City of Scottsdale permitting voluntary referendum be adopted?

A "Yes" vote shall have the effect of giving the City authority to refer ordinances to the voters for approval or disapproval on the City Council's own motion.

A "No" vote shall have the effect of continuing the lack of authority of the City Council to voluntarily refer legislative matters, except Charter amendments, to the voters of the City.

- 1. The deadline for absentee voting is February 12, 1982.
- 2. YOU MAY VOTE AN ABSENTEE BALLOT for this Election if you qualify under any of the following conditions:
  - a. Physically disabled
  - b. 65 years of age or older
  - c. Live more than 15 road miles from the polling place
  - d. Absent from the precinct on Election Day
  - e. The tenets of your religion prevent you attending the polls on the day of the Election.
  - f. Legally blind

## 3. TO OBTAIN AN ABSENTEE BALLOT:

- a. Appear in person at the office of the City Clerk, 3939 Civic Center Plaza, Scottsdale OR
- b. Submit a written request to the City Clerk, 3939 Civic Center PLaza, Scottsdale, AZ 85251, before February 12, 1982, indicating one of the above conditions.
