Descriptive Title

This proposition clarifies the City's authority to act to preserve and enhance the environment by a specific provision of such authority as it may relate to the ecology.

A "Yes" vote shall have the effect of clarifying the authority of the City to act to preserve and enhance the environment as it may relate to the ecology.

A "Yes" vote shall have the effect of authorizing the City to control, manage and regulate wastewater and effluent, including acquiring, constructing, operating and maintaining treatment and management facilities; levying and collecting fees; licensing, purchasing and selling recovered resources; imposing penalties for unlawful disposition; and contracting with private or governmental entities for disposal.

Descriptive Title

This proposition would provide the City with the authority to contract with a private entity, as well as a governmental entity, for the disposal of garbage and all other solid waste.

A "Yes" vote shall have the effect of authorizing the City to contract with a private entity for the disposal of garbage and all other solid waste.

A "Yes" vote shall have the effect of limiting the term of office of mayor and councilman, each office being considered separately, to three consecutive terms.

Descriptive Title

This proposition removes real property ownership as a qualification for the offices of mayor and councilman.

A "Yes" vote shall have the effect of removing the qualification of real property ownership as a condition of holding the offices of mayor and councilman.

PROPOSED AMENDMENT TO THE SCOTTSDALE CITY CHARTER BY THE CITY COUNCIL.

SHALL ARTICLE 6, SECTION 11, RELATING TO TRANSFER OF APPROPRIATIONS, BE AMENDED?

Descriptive Title

This proposition would permit the City Council, at the request of the City Manager, to transfer unencumbered appropriations from one office, department or agency of the City to another, which presently can only be done within the last three months of the fiscal year.

A "Yes" vote shall have the effect of authorizing the City Council, at the request of the City Manager, to transfer unencumbered appropriations between City offices, departments and agencies of the City at any time during the fiscal year.

A "No" vote shall have the effect of limiting the City Council's ability to transfer unencumbered appropriations from offices, departments and agencies of the City to the last three months of any fiscal year.

Descriptive Title

This proposition would remove the present charter requirements that the Mayor sign all contracts and that the Clerk number and register all contracts. The proposition also directs the Council to act by ordinance to establish the authority for signing contracts and the procedures for their execution.

A "Yes" vote shall have the effect of removing the requirement that the Mayor sign all contracts and that the Clerk number and register all contracts, and would direct the City Council to act by ordinance to establish the authority for signing contracts and procedures for their execution.

SHALL ARTICLE 8, SECTIONS 3 AND 4, RELATING TO PURCHASING AND BIDS, BE REPEALED AND REPLACED BY A NEW SECTION 3, WITH THE SAME SUBJECTS, RENUMBERING THE SECTIONS WHICH FOLLOW IT TO CONFORM NUMERICALLY WITH THE AMENDMENT?

Descriptive Title

This proposition repeals the present charter provisions regarding the City's purchase of goods and services, including bidding requirements, and requires the Council to enact an ordinance specifying the conditions and procedures for bidding when the City contracts for goods and services, renumbering sections to conform as appropriate.

A "Yes" vote shall have the effect of repealing present Charter provisions relating to the purchase of goods and services, and bidding therefor, and requiring the City Council to act by ordinance to specify the conditions and procedures for bidding when the City contracts for goods and services, renumbering Charter sections as necessary.

This proposition authorizes the City Council to appoint an internal auditor, who would examine and verify such City affairs as the Council might direct. An auditor so appointed would report directly to the City Council.

A "Yes" vote shall authorize the City to adopt ordinances relating to the external maintenance of structures and land, to levy and collect assessments therefor, and to file liens on real property to collect amounts expended by the City for such purposes.
