

RESOLUTION NO. 6496

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA DECLARING OFFICIAL THE CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE RUNOFF ELECTION HELD MAY 18, 2004; DECLARING THE ELECTION OF THE MAYOR AND THREE COUNCIL MEMBERS; AND DECLARING OFFICIAL THE CANVASS OF VOTES CAST IN A SPECIAL ELECTION, HELD CONCURRENTLY WITH THE RUNOFF ELECTION, ON THREE QUESTIONS VOTED UPON BY THE QUALIFIED ELECTORS OF THE CITY.

WHEREAS, the City of Scottsdale, Maricopa County, Arizona, held a Runoff Election on May 18, 2004, pursuant to Article 9, Section 1, of the Scottsdale City Charter, for the purpose of electing a mayor and three council members for the City of Scottsdale; and

WHEREAS, a Special Election was also held on May 18, 2004, at the same time as the Runoff Election, for the purpose of presenting Questions 1, 2, and 3 to the qualified electors of the City; and

WHEREAS, Question 1 proposed a special transaction privilege tax of .15 percent (.15%) to provide funding to acquire land and interests in land, and construct improvements thereto, for the McDowell Sonoran Preserve; and

WHEREAS, Question 2 proposed the issuance and sale of General Obligation Bonds to finance the acquisition of land and interests in land, and construction of improvements thereto, for the McDowell Sonoran Preserve; and

WHEREAS, Question 3 proposed a special transaction privilege tax of .10 percent (.10%) to provide funding for enhanced public safety services and capital needs; and

WHEREAS, A.R.S. 16-642 requires that the City Council canvass the returns of the election not less than six (6) days, nor more than fifteen (15) days following the election; and

WHEREAS, the Council of the City of Scottsdale, having canvassed the returns of the Runoff Election and the Special Election, find the returns to be as stated in this resolution,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Scottsdale as follows:

1. The results of the canvass having been determined, the official canvass of the City of Scottsdale Runoff Election and Special Election held on May 18, 2004 is as follows:
 - a) A summary of the number of ballots cast in each district for each candidate for the offices of mayor and council member and Questions 1, 2, and 3 is shown on Exhibit A, which is attached and incorporated by this reference.
 - b) A precinct group detail of the number of ballots cast by district is shown on Exhibit B, which is attached and incorporated by this reference.
2. The following named candidate, having received the greatest number of votes cast in the Runoff Election, was elected to the office of mayor:

3. The following named candidates, having received the first and second highest number of votes cast in the Runoff Election for the office of council member, were elected to four-year terms:

Jim Lane
Ron McCullagh

4. The following named candidate, having received the third highest number of votes cast in the Runoff Election for the office of council member, was elected to a two-year term:

Kevin Osterman

5. Question 1, which received a number of votes that was more than a majority of the votes cast, was approved by the qualified electors.
6. Question 2, which received a number of votes that was more than a majority of the votes cast, was approved by the qualified electors.





UNA RESOLUCIÓN DEL CONCEJO DE LA CIUDAD DE SCOTTSDALE, CONDADO DE MARICOPA, ARIZONA DECLARANDO EL ESCRUTINIO OFICIAL DE LOS VOTOS EMITIDOS EN LA ELECCIÓN FINAL DE LA CIUDAD DE SCOTTSDALE QUE SE CELEBRÓ EL 18 DE MAYO DE 2004; Y DECLARANDO LA ELECCIÓN DEL ALCALDE Y TRES MIEMBROS DEL CONCEJO; Y DECLARANDO EL ESCRUTINIO OFICIAL DE LOS VOTOS EMITIDOS EN UNA ELECCIÓN ESPECIAL QUE SE CELEBRÓ JUNTO CON LA ELECCIÓN FINAL DE TRES CUESTIONES SOBRE CUALES VOTARON LOS ELECTORES CAPACITADOS DE LA CIUDAD.

VISTO QUE, la Cuestión 1 propuso un impuesto sobre negocios de transacción especial del .15 por ciento (.15%) para proveer financiamiento para adquirir terreno e intereses en terreno, y para la construcción de mejoramientos a eso, para la McDowell Sonoran Reserve; y

VISTO QUE, la Cuestión 2 propuso la emisión y venta de Bonos Financieros de Obligación General para pagar por la adquisición de terreno e intereses de terreno y la construcción de mejoramientos a eso para la McDowell Sonoran Reserve; y

VISTO QUE, la Cuestión 3 propuso un impuesto sobre negocios de transacción especial del .10 por ciento (.10%) para proveer financiamiento para mejorar los servicios de seguridad pública y necesidades de capital; y

VISTO QUE, los Estatutos Revisados de Arizona 16-642 ordenan que el Concejo de la Ciudad complete el escrutinio de los resultados de la elección no menos de seis (6) días ni más de quince (15) días después de la elección; y




